Caerus Piceance LLC respectfully requests continued TA status for the subject well, this well was TA'd for construction, drilling, and completions on the NPR 25B-10-596 pad. The well was TA with a RBP set at 5945' with 3 sacks of sand on top of the plug on 11/13/2017. There is a TA cap on this well to ensure it is closed to the atmosphere. This well is completed in the Williams Fork formation. Caerus will return this well to production when the frac on the pad is complete. A formal MIT was done on this well on 1/23/2018.
