Caerus Piceance LLC respectfully requests continued TA status for the subject well, this well was safety shut in for construction, drilling, and completions on the NPR G09 pad. There is a RBP set @ 5976' with 2 sacks sand. The master valve on the wellhead is closed to ensure the well is closed to the atmosphere. This well is completed in the Williams Fork formation. Caerus will return this well to production when the frac on the pad is complete. In lieu of a formal MIT this well was pressure tested for 15 min at 413 psi and had a good test, please see attached operations summary.
