Noble Energy respectfully requests continued TA status. The well is closed to the atmosphere via a CIBP bridge plug set at 6464' on 12/20/2018. The well is closed to the atmosphere and locked out and tagged out at the master valve. The well was completed in the J Sand and Niobrara formation. This well was TA'd for an off-set frac, HighPoint's Wetco Wetco 4-63-5-5764B Pad. Noble will return the well to production once a rig is available - unknown time frame as we are currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Form 5A to change the status to TA was submitted on doc # 401927518. Initial pressure test is attached. Noble will run an MIT if the well is still TA'd after two years.
