Hi Mr. Joyner,

Paradox Upstream LLC, recently acquired the Cocklebur Draw #1, #3, & #4 from Merrion Oil & Gas. Since acquiring them, two are now producing again (#1 & #4) and one is still being evaluated (#3). The COGCC has contacted us to let us know that before we acquired them and returned them to production, the wells went more than 24 months without production. Because of this, the COGCC is requesting a bradenhead test for all 3 of these wells to confirm wellbore integrity.

I've been asked by the COGCC to contact the BLM and ensure that you are aware of the plan to move forward with bradenhead testing to confirm integrity. Please let me know when you have received this so that I may inform the COGCC. If you have any questions, feel free to call.
