HighPoint plans to eliminate the 7" casing string, run only a 4.5" production string from TD to surface, and use a premium cement blend to ensure formation isolation and prevent gas migration for all wells on the pad. In addition, a FIT test on each well will be performed to ensure that surface casing set depth is protective and appropriate for any anticipated wellbore situation. Please see the attached FIT procedures, wellbore diagram, and BOP diagrams. In addition, below please find the list of wells and current surface casing setting depths.
