#### COMMENTS:

The wellhead spacing on the CC 604-41-32 pad has changed from 7.5' centers to 10' centers to accommodate safe drilling and completion practices. Because of these changes, the CC Federal 0697-03-01W and the CC 0697-04-SWD1 will have new slots. The pad is a sufficient size to accommodate this change without making any changes to the pad disturbance or pad layout. Also, ten of the wells will be deepened to the Corcoran; the BHL footages will not change. The CC Federal 0697-04-01E will be shortened from the Corcoran to the Rollins; the BHL footages will not change.
