Form 42 High Bradenhead Pressure During Stimulation

After the pre-stimulation Form 17 test was completed, the initial elevated bradenhead pressure present on the Herren 1B-33H was blown down through a surface line to a combustor. The bradenhead was then shut in and pressure build was monitored. Periodic bradenhead pressure relief was performed through the surface line to the combustor in between frac stages on this well.

During stimulation on this well, the bradenhead was shut in to allow for surveillance of the production casing / surface casing annulus, in order to provide early identification of frac fluid in the annulus. None was observed. Pressure relief of the bradenhead gas has been done much less frequently since February 7th, 2019, as the pressure has stabilized in the ~240 psig range.

Real time, instantaneous bradenhead pressure is collected and stored by the Crestone SCADA system. A chart of the bradenhead pressure is attached, for reference. Crestone will continue to monitor pressures through the SCADA system and scheduled Form 17 tests.
