## Comment

COGCC Staff conducted a review of the well files for the Bunker 3A /Pad Location and found that Operator reported the two new wells as on production starting in or before August 2018 and continuing through the most recent reported month (December 2018). The latest Date of First Production for the two new wells on the Location was August 2, 2018, (API 05-069-06499 and 069-06500), indicating that no ongoing operations are required at the Location as of that date. Because the Location is on cropland, Operator was required to perform interim reclamation no later than November 2, 2018.

Based on field observations from February 13, 2019, the Operator has failed to perform interim reclamation by the required date.

## Corrective Action

Comply with Rule 1003.b. Corrective action date is being back dated to when Interim Reclamation activities should have been completed.
