<p>Final Reclamation Requirements:</p> <p>1) When the Operator uses the FIRR to document the completed corrective action work, Operator shall report proof that a certified or qualified contractor performed the corrective action work.</p> <p>2) Until Final Reclamation is achieved and passed by the Director, Operator shall submit bi-weekly reports during the growing season in order to evaluate reclamation progress. If Noble observes areas failing to establish vegetation or failing progress toward the vegetative standard, it shall use whatever measures it deems appropriate to advance toward the uniform vegetation standard of 80% of reference area levels. Until Final Reclamation is achieved and passed by the Director, Noble shall continue to submit bi-weekly reports using a Form 4, Sundry Notice, documenting the progress. Once the standard is met, Noble will submit a Form 4, Sundry Notice, requesting a Final Reclamation inspection to verify compliance with Rule 1004.c.</p>	binschusc	02/12/2019
