GROUND WATER SAMPLING

Uses of Ground Water Sampling Section

Request an Exception to Ground Water Sampling Requirements in Greater Wattenberg Area Rule 318A.e(4) or in Statewide Rule 609.c. Request a Previously Sampled Water Source in the COGIS database be used to meet sampling requirements as described in Rule 609.d.(3).

NOTE: If this Sundry Notice is being submitted to request a Ground Water Sampling Exception it cannot be used for any other purpose except requesting the use of a Previously Sampled Water Source in the COGIS database.

One water well was identified within the one half mile buffer of the Oxbow 0880 pad. The water well located within the buffer, permit number 29-WCB and receipt number C290029, is no longer operational. A conversation with the landowner's representative, TRK Properties - Kallen Kimszey on 9/24/2018, identified that well was previously drilled but no longer in operation. Absaroka field personnel visited the location and confirmed the well's status on 9/25/2018. Multi-well exception also applies to PRU 0880 6-29H17 (API# 05-057-06613 and 05-057-06614), PATRIOT 0880 12-32H5 (API# 05-057-06615), PATRIOT 0880 15-32H5 (API# 05-057-06616), PATRIOT 0880 14-32H5 (API# 05-057-06617), AND PATRIOT 0880 13-32H5 (API# 05-057-06618).
