The source of the sheen looks to have come from a vehicle or drip truck. All work has been remediated and half a yard of soil was removed and hauled to our contaminated soil remediation area at the Burro facility.

We Took precautionary steps and added double wall tank and hard lined from separator to tank to prevent produced water to discharge on soil. Produced water in vessel was checked for contaminates and none were present.
