This was to be a Final Reclamation Inspection for PA Well API#077-07350; Spud 7/11/1956. Plugging Record in Files has PA Date of 9/14/1960; though what appears to be Well head remains installed in irrigated Hay field approximately 225 feet Southwest of residence. Surface owner said that when she purchased property in 2004 she was told that Well head belonged to somebody else and has been used as Cattle rub in intervening years.

Inspection is being referred to Orphan Well Program. It appears that information was uploaded to digital files (Documents) as late as 2/13/2019 which may be why it showed up as a high Reclamation Priority. Surface Owner Contact information will be forwarded to Orphan Well Reclamation Specialist.
