2. RU wireline company.
3. TIH with CIBP. Set BP at 6460'. Top with 2 sks 15.8#/gal CI G cement.
4. TIH with casing cutter. Cut 3 1/2" casing at 1700'. Pull cut casing.
5. TIH with tubing to 1815'. RU cementing company. Mix and pump 253 sks 15.8#/gal CI G cement w/ 2% CaCl down tubing (Pierre coverage from 1815'-1400').
6. Pickup tubing to 554'. Mix and pump 345 sks 15.8#/gal CL G cement down tubing. Cement should circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.
