Comment:

This location is not in compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 04/05/2017. Operator has failed to perform Final Reclamation at the well location and the associated access road. There is no evidence to suggest that Final Reclamation activities were performed (e.g., drill rows, mulch, or any desirable vegetation) and there is no evidence that the access road has been recontoured. Refer to the attached inspection photos.

Note: COGCC Staff did not inspect the access road that appears to continue south towards another PA well location (123-19365).

Corrective Action: **Comply with Rule 1004. Corrective action date is being back dated to when all final reclamation activities should have been completed.**
