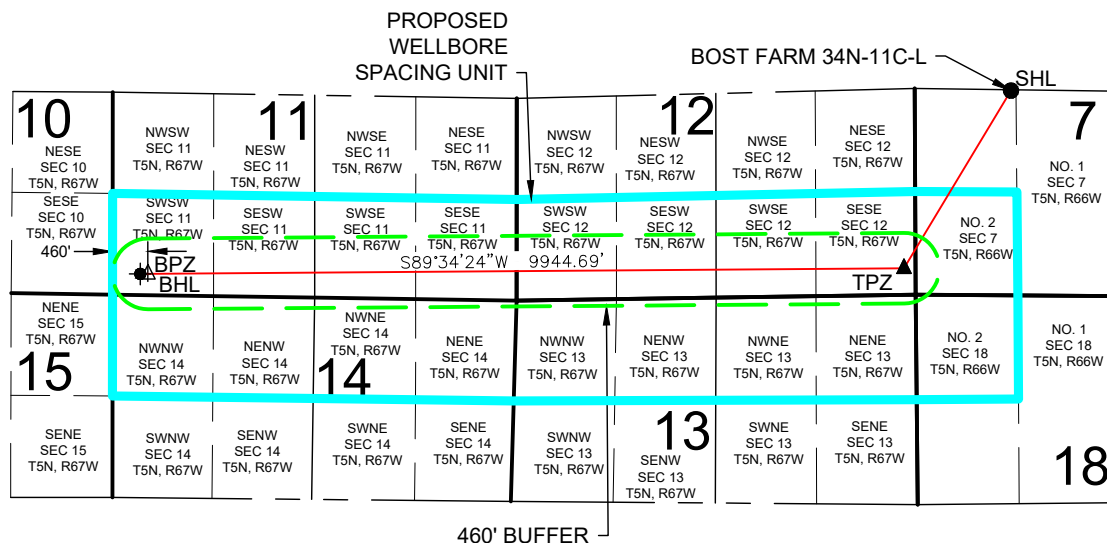

# BOST FARM 34N-11C-L WELLBORE SPACING UNIT

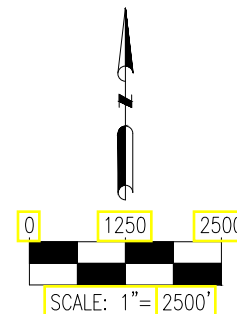


**BOST FARM 34N-11C-L WELL TO BE LOCATED 2666' FSL AND 1254' FWL, SEC 7, T5N, R66W**
