Comment: **This location is not in compliance with Rule 1004a due to debris left on site and the eastern part of the pad and the access road remain. Well was plugged 7/31/2017 and work should have been completed by 7/31/2018. Gravel remains along parts of pad and the access road which has not been re-contoured or re-graded and decompacted to meet the adjacent terrain. No 502b variance request for the access road or part of the pad remaining is on file. Please refer to the attached inspection photos for more detail.**

Corrective Action:	Perform reclamation in accordance to Rule 1004. Remove gravel from the eastern part of the pad and access road; perform compaction alleviation and re- contour/re-grade. Remove remaining debris. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Operator is directed to perform corrective actions outlined on this inspection report immediately. Doing so may decrease the duration of the alleged violations and the penalties that may be assessed pursuant to Rule 523.	Date	07/31/2018
