<p><b>COGCC Inspection Report Summary</b>  On Thursday February 28 2019 at approximately 0900hrs Inspector Randy Silver, conducted a Preliminarily on-site inspection at the Richey #26-1-22HC. Operated by Great Western Operating LLC, (API#05-123-44767) in Weld County Colorado. I returned on Monday March 4 2019 to complete official inspection. At that time, I reviewed location COA's did not find any documentation allowing this type of use on location, While performing a routine inspection I observed what appeared to be 8 trailers used for occupancy. Upon driving on location I was met by a gate guard at entrance of location. He informed me the trailers on location were used to provide living quarters for drilling hands from multiple wells. I saw 8 trailers on location approximately 90ft from Well Heads. I also observed electrical and sewage components for the trailers.  During this inspection the following possible compliance issues were observed:  Trailers on location (Unused equipment) COGCC rule 603 f. CA date 4-4-2019. See attached photo's.  Reclamation issue with use of site COGCC rule 1003 b. CA date 4-4-2019. See attached photo's.</p> <p>I spoke with Jeff Lofton Drilling supervisor for Great Western at approximately 1430hrs on 3 -1-19. I asked him if he submitted and permits or forms to the state or county for the man camp on location. Jeff Lofton informed me he was no away of what had been submitted he told me to contact Miracle Pfister who was in charge of doing that. I call her she did not answer I left voice mail. I then proceeded to contact Weld county I was put in contact with Hana Dutrow, Compliance specialist, she informed me someone would go out and perform inspection on 3-5-2019. She also informed me no permits had been submitted to the county for such us of the location.  A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
