COMMENTS

One Water Source (known by the Colorado Department of Water Resources as permit receipt number 9085753) was identified within a 0.5 mile radius of the JW Powell #23-35 production wellhead (Site). No other Water Sources were identified within a 0.5 mile radius of the Site.

On February 27, 2019, a representative of the Water Source owner (Mr. Carl Colgin, Town of Rockvale) was contacted via phone to obtain information regarding specifics of the Water Source. Mr. Colgin stated that the Water Source consists of a "gravity feed sand trap" that is completed in a shallow alluvial aquifer which collects and transports water through an underground piping system. Mr. Colgin also stated that a pump is not present in the well, there is no tap at the surface, and sample collection from the Water Source would not be possible without the use of specialized sampling equipment. Based on this information, the well is unsuitable for sampling pursuant to COGCC Rule 609.b.5. and Fremont is requesting an exception from the requirements of Rule 609 for the Site.
