This Form 4 Sundry Notice is being submitted to comply with Condition of Approval (COA) #2 listed on COGCC Document 401914437 associated with the Basin Pipeline WC-4 Vault Release (Remediation #12401). In the section below, the COA is listed first followed by the information requested from the COA.

eForm 19: 401914437 – COA #2: Submit relevant data from the pressure monitor on the failed 3/8-inch stainless line via eform 04 Sundry Notice to the attention of Mark Schlagenhauf. Include sufficient information from normal operations prior to the spill to identify the normal operating pressure of the line as well as pressure monitoring data from during and after failure of the line. This Sundry notice shall also include a summary of when and how the spill was brought to the Operator's attention in addition to a description of how similar occurrences will be prevented in the future.

Compliance Description: The normal operating pressure range prior to the failure at the Basin Pipeline WC-4 Vault was between approximately 380-650 psi. During and after the failure the pressure reading was 0 psi due to flow through the line being stopped and the line depressurized until corrective actions could be made. The release was called into the Caerus Operations Control Center (OCC) at approximately 1311 on Monday, January 14th, 2019. To prevent a similar occurrence in the future, the valve manifold at the WC-4 Vault was removed and replaced with 10" diameter stainless steel pipe on February 20th, 2019.
