Description of Abandonment

Flowline was disconnected from wellhead and from separator. Flowline was flushed with 25bbls fresh water prior to plugging. Flowline was verified free of hydro carbons with LEL monitor. Line was capped on both ends with 120lbs of slurry per state NTO, then backfilled on both ends.
