COMMENTS:

Whiting requests permission to temporarily abandon this well due to completion economics. Due to increased levels of production communication from high density pad drilling, completion has been delayed. When oil prices reach a level to meet a rate of return of 20% the well will be completed and produced. The well is closed to the atmosphere by cement at 13729' and a night cap with bull plug and needle valve at surface. The well was drilled in December 2016 and has not been stimulated/completed to date.
