## OPERATOR COMMENTS AND SUBMITTAL

Comments

In Drilling Tab, distance proposed wellbore to another operator is 33 feet to KAMMERZELL 29-6H6 (05.123.17940) using Anti-Collision Report. In Spacing Tab, distance proposed wellbore to offset same formation is 218 feet to Sanford 40N-27B-XR using Plan View Map Measurement.

The acreage was calculated using Title Opinions from our Attorneys. They take into account all official surveys that become record which may add or, in some cases, reduce a quarter/quarter from the standard 40.00 acres.

In Spacing Tab, the unit configuration did not fit so adding here: 5N-66W Sec 27: All; Sec 28: All; Sec 29: All; Sec. 30 All.

SRC has obtained written permission from the surface owner by way of Surface Use Agreement (SUA) which has waivers for Rule 318A.a & 318A.c. See page 5, Section 6.A.
