INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Initial Form 19 was submitted 2/18/2019. Snow pack kept the material from penetrating through the ice and into the ground surface. The temperature was 10F with no precipitation. The spill area was cleaned by scraping the material with a front-end loader, loading it into a transport truck, and hauling to Twin Enviro for disposal in Milner, CO. A Supplemental Form 19 was submitted 2/27/2019. The COGCC approved the Form 19 Supplemental with a condition of approval that soil samples be collected and submitted via Form 27.

On 3/6/2019, 2 soil grab samples were collected (1-2 inches in depth) within the spill area to evaluate the potential for soil to be impacted by the spill. Based upon visual observations, one sample was collected in most impacted location within the spill area. Samples were screened for the presence of hydrocarbons with a photoionization detector (PID) and submitted to Pace/ESC Labs for COGCC Table 910-1 Analyses.
