Construction Inspection was conducted on 2/26/19 by I, Russell Beam, COGCC Reclamation Specialist at the location.

The following Corrective Actions were observed during the Inspection.

1002.f.2 Stormwater management. BMPs were not installed around the entire perimeter during the initial construction phase of the location and no stabilized outlets were observed on location during construction – CA Date 2/20/2019.

1002.C Protection of Soils. Topsoil stockpile has not been temporarily stabilized – CA Date 2/26/2019.

Operator is directed to perform corrective actions outlined on this inspection report immediately. Doing so may decrease the duration of the alleged violations and the penalties that may be assessed pursuant to Rule 523.
