Reasoning for SHL shift– Based on offset well density analytics our geophysical and reservoir team prepared, we decided to more conservatively space wellbore. Therefore, in lieu of skipping surface slots, skidding extended distances, minimizing unnecessary disturbance and having oddly spaced wellheads on the pad, we decided to drill in consecutive well slots for the rig.
