**OPERATOR COMMENT AND SUBMITTAL**

Comment: Wesco has complied with all of the corrective actions listed on the field inspection form (document number 682504293). During February 25-28 (2019) and March 7-12 (2019) Wesco staff and contractors completed the following: removed approximately 24 cubic yards of contaminated soil from the site facility and hauled material to Buffalo Ridge Landfill, addressed the weeds on site, removed the power poles, reclaimed additional portions of the facility road, recontoured the facility and road, added manure for fertilization and seeded the site facility using NRCS suggested seed mix, and crimped straw on seeded area to enhance seed stabilization. Waste disposal manifests will be submitted when available.
