I'd like to request to remove the COA on the Form 2 for this well requiring the remediation of the Asher 1 (05-014-05579) per the DJ Basin Horizontal Offset policy by virtue of it being greater than 1500' from this Coyote Trails wellbore. The Asher 1 was drilled and abandoned in 1951 and its TD is at 5625. Since this well will be completed in the Nio/ Codell formation, stimulation will occur at least 2000' below the Asher 1's TD.
