Comment: Temporary BMPs have been installed (ditch and silt fence BMP) around the entire perimeter during the construction phase of the location. Silt fence BMP is in need of maintenance from the recent storm on March 13th. Operator representative on location indicated that repairs were already on order. Operator has plans for more permanent BMPs upon the completion of pad construction.

BMPs shall be selected based on site-specific conditions, such as slope, soil type, vegetation cover, and proximity to water bodies, and may include maintaining in-place some or all of the construction BMPs until the Location is abandoned and final reclamation is achieved pursuant to Rule 1004. BMPs shall be installed in accordance with good engineering practices.
