General Comment:

This is an environmental follow up inspection to COGCC inspection 693900054. Any corrective actions from previous inspections that have not been performed are still required.

COGCC inspection 693900054 noted possible stained soils from historic releases in the project area. Environmental inspection during dry conditions found that these stained soil observations were most likely from wet carbonaceous soils commonly found in the area. No hydrocarbon stained soil was observed during environmental inspection. See attached photos.

Follow up inspection to document compliance with other corrective actions on COGCC inspection 693900054 still required.
