3. TIH with CIBP. Set BP at 6603'. Top with 2 sxs 15.8#/gal CI G cement.

4. TIH with CIBP. Set BP at 6330'. Top with 2 sxs 15.8#/gal CI G cement.

5. TIH with tubing to 1800'. RU cementing company. Mix and pump 40 sxs 15.8#/gal CI G cement down tubing (Pierre coverage from 1800'-1300').

6. Pick up tubing to 595'. Mix and pump 50 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface. TOOHH with tubing.

7. Cut surface casing 6' below ground level and weld on cap.
