Bison Oil & Gas II is requesting to increase the disturbance following interim reclamation from the currently permitted 1 acres, to 2.1 acres. Interim reclamation has been performed at the State 16-7-60 1H location by the previous responsible operator, according to a preliminary report and field assessment conducted prior to the pad acquisition by Bison Oil & Gas II in 2018. At this time, further reclamation will not be performed as the current pad size and layout are necessary to support ongoing operations.
