INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A subsurface assessment was conducted to determine if petroleum hydrocarbon impacts to the subsurface media existed from a former earthen pit at the site. The former pit was identified in a Colorado Oil and Gas Conservation Commission (COGCC) Field Inspection Form (Document No. 689500929). The Site Map depicting the former earthen evaporative pit location is attached as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On February 27, 2019, two soil borings were advanced to approximately 6 feet below ground surface at the former pit location, as identified during the COGCC inspection. The soil borings were continuously field screened using a photoionization detector (PID). Soil staining, odor, and/or elevated headspace readings were not observed or identified through PID screening; the highest PID reading recorded was 3.8 parts per million. Based on the field screening results, a soil sample was collected from the total depth of each boring and submitted for laboratory analysis of total petroleum hydrocarbons (TPH), benzene, toluene, ethylbenzene, and total xylenes (BTEX), pH, and specific conductivity (EC). Laboratory analytical results for soil samples SB01@6' and SB02@6' indicated that BTEX, TPH, pH, and EC concentrations and levels were in full compliance with COGCC Table 910-1 allowable levels. The soil sample analytical results are summarized in Table 1, and the analytical report is attached.
