**General Comment:**

COGCC Environmental Inspection to determine the status of pit facility ID 119743 and 118462.

The pit location was determined based on historical documents and aerial imagery. Pit 119743 is a duplicate of pit 118462. COGCC personnel found no surface indication of a pit present in the location. The pit status has been changed to closed. However, no associated remediation or site investigation has been conducted. Should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or if ground water is found to be impacted, then further investigation and/or remediation activities may be required.
