The Jurisdictional Agency determination was based on information contained in or added to the Application. Review by the professional staff of the Colorado Commission indicates that this well is an (New) (~~Old~~) well. The well produces from the Niobrara

reservoir(s); Schramm field, Yuma County, Colorado. This well is more than 2.5 miles from any well which produced gas in commercial quantities on or after January 1, 1970 and before April 20, 1977.

This conclusion was originated by examination of the contents of the application as prepared and presented by the applicant. Statements in the application describe the search made, the records reviewed and their location. The applicant is also a purchaser in this area, and purchases gas from this well.

Which show this well is more than 2.5 miles from a marker well.
