It was reported on the Form 27 that monitoring wells were installed as 1" pvc, only one well was observable (seen in attached photo). Sandridge should assure that the wells are not allowing any fluid from the surface to the subsurface. Remediation project communication will continue on the Form 27 and email. Well was Shut-In at time of inspection.
