**Operator Comments:**

Verdad Resources would like to change the SHL from 1784FNL to 1704FNL. All associated documents are attached. The nearest well in the same formation is Timbro 9-59 8A-9-6.

After drilling the Timbro 959 8A-9-2 and Timbro 959 8A-9-4 the structural complexity from a W-E orientation wouldn't allow for a majority in zone Codell well, and with the next well in line being a Codell well, we will have to change our plans.

In order to accommodate this change we will buy some time by skidding to the Timbro 959-8A-9-9 and coming back to our middle development of the pad after the Timbro 959 8A-9-9 and Timbro 959 8A-9-8 wells have been drilled. With the surface slot currently set as the Timbro 959 8A-9-6, we will need to sundry this well to the previously permitted Timbro 959-8A-9-5 lateral (BHL) path for better Nio spacing. Thank you for your understanding.
