Comment:	While moving drilling rig (starting on 3/22/2019) some of the oil based mud tank was spilled due to mud at the location. About 3-5 bbls (may include snow melt) spilled on containment (plastic liner under rig) and ~1 bbl was recovered, including stained soils, off containment. Operator had vac truck on location on 3/27/2019 to remove OBM that left containment and also installed a berm to prevent further flow off containment (see attached photos) until area is dry enough to remove rest of OMB and liner that will be completed on 3/28/2019 per operator. Check for integrity of containment when removing it and remove any additional material if needed.
