<p>On 2/22/2019; I received a complaint #200446986 in regard to public safety around the wellhead, pump jack and electrical equipment. I, Tom Peterson, COGCC field inspector, performed an inspection of the facility at approximately 12:30 PM on 2/22/2019. The complainant states witnessing children playing around the equipment. The current fencing on location consists of pipe fencing partially covering the pump jack weights and no fencing around the wellhead or electrical equipment. See attached photos.</p> <p>Rule violations found during the inspection are: Rule 605. c. (3) with a corrective action date of 3/29/2019, Rule 210. b. with a corrective action date of 3/29/2019.</p> <p>KPK Morgan A2, location ID 318000.</p> <p>Original inspection was performed on 2/22/2019 in response to complaint# 200446986</p> <p>On 4/4/2019, I Tom Peterson, along with supervisor Adam Kraich, performed a follow up inspection to document #674301660 at approximately 10:00 hrs. The prior inspection document identified three corrective actions.</p> <ol style="list-style-type: none"> <li>1. Well signage is faded and illegible, citing rule 210.b</li> <li>2. Well signage is missing emergency contact information, citing 210.b</li> <li>3. Equipment at wellhead, pumping unit and prime mover are unsecured, and sit in the middle of a developed neighborhood. Citing 605.c</li> </ol> <p>The Corrective action time frames assigned to these corrective actions expired 3/29/2019.
