Comments There is a surface water area approx 77' East of the proposed well pad and a windmill exists approx. 1428' West of the well head. The ROW of C.R. 3S falls approx 446' North, an overhead powerline falls approx. 506' North and the West ROW of C.R. 32 falls approx 280' East of the proposed well pad. The only improvements that lie within the 500'-1000' buffer area of the wellsite are C.R. 3S, C.R. 32 and the powerline from our wellbore.
