## COMMENTS:

Inspection #689400617 listed an unknown pit type and no permit for a pit on file so a Form 15 submittal was requested. After review, we found that this well was permitted with a reserve pit on site when it was drilled in 1993. Upon inspection of the site, we noticed that a minor depression had formed in this area and we have since filled and leveled this depression as of 11/10/2017. After discussion with Curtis Conklin regarding the original well drilling permit that included a reserve pit, wherein we discussed how we corrected this situation, he indicated that no Form 15 is required.
