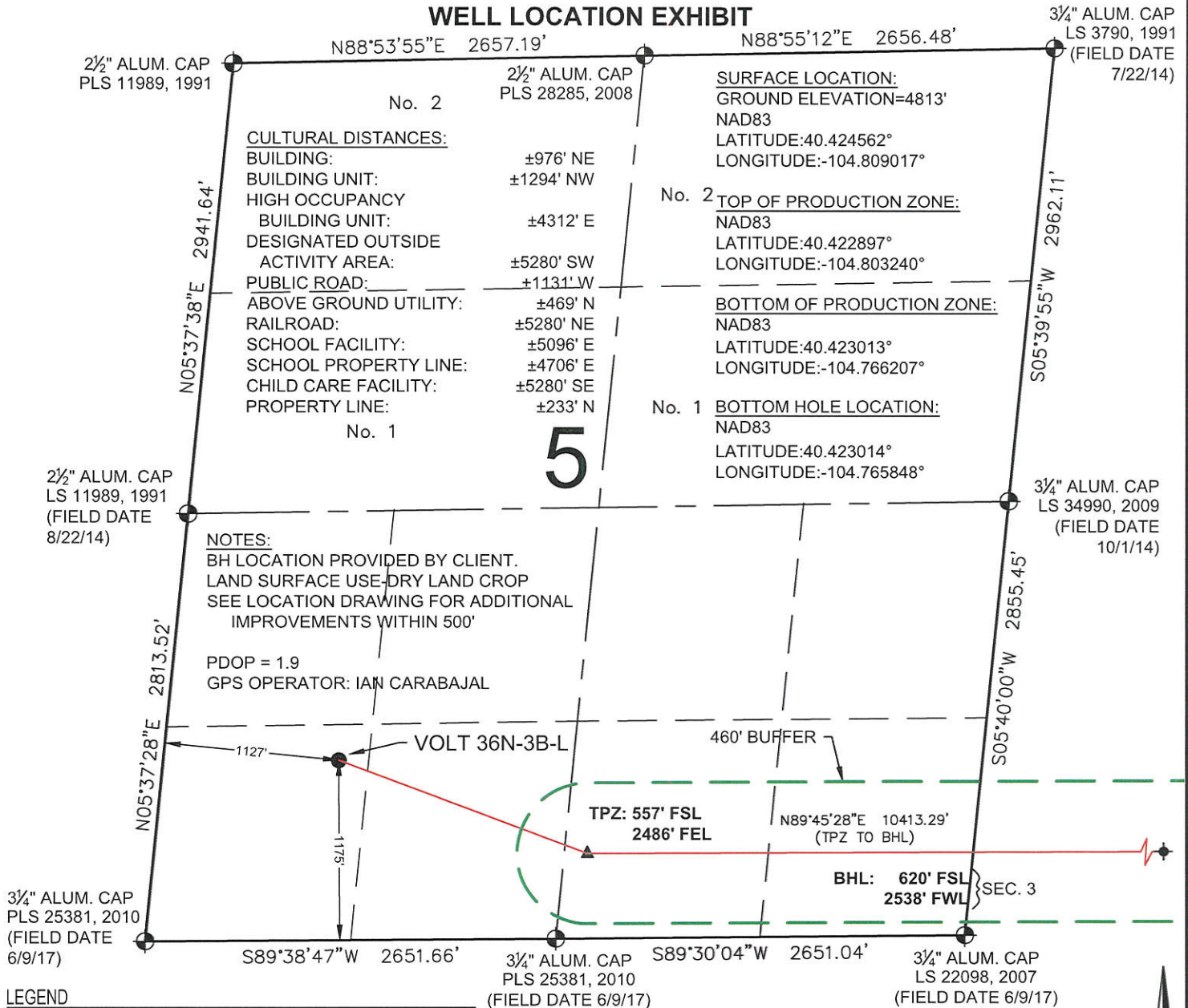


# VOLT 36N-3B-L WELL LOCATION EXHIBIT
