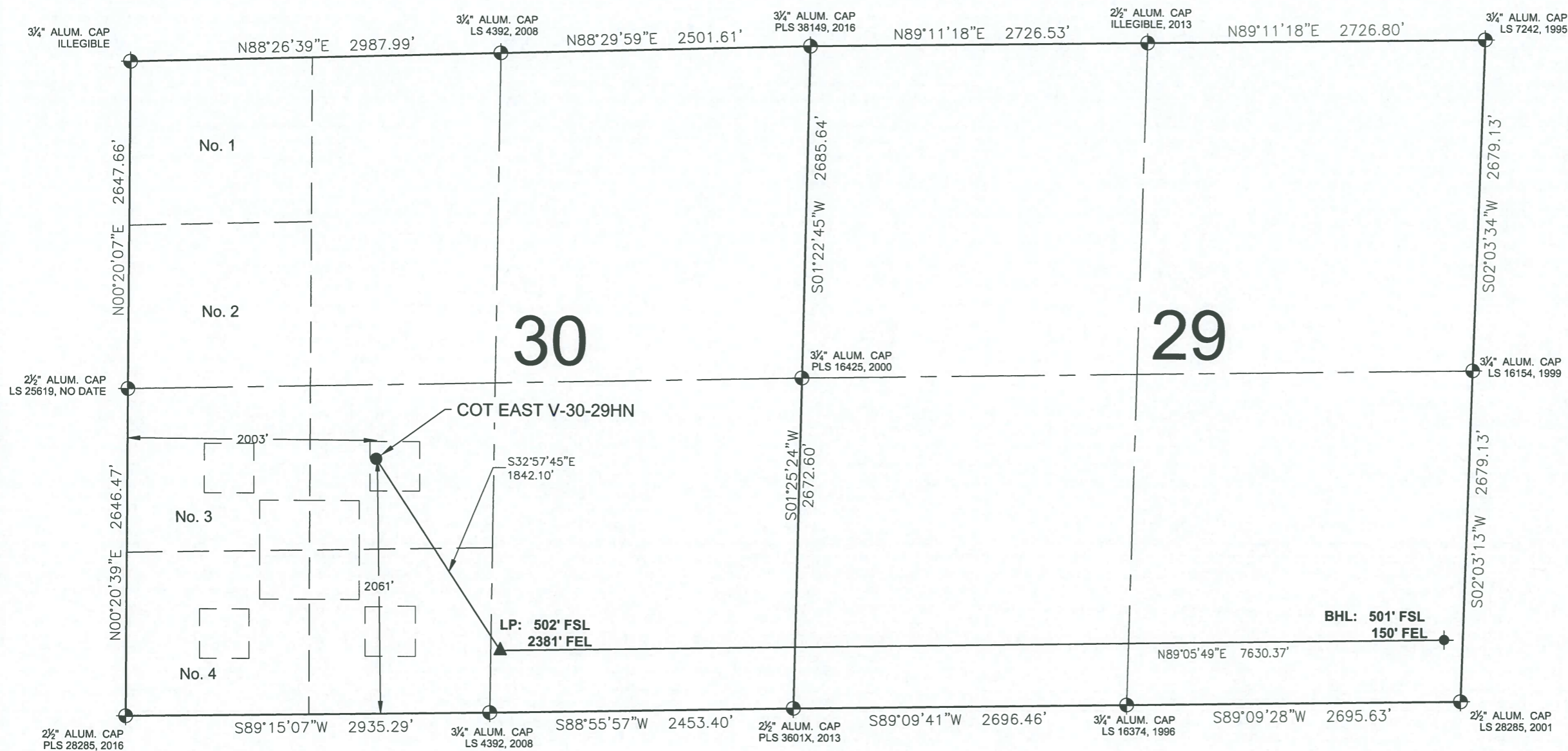


COT EAST V-30-29HN WELL LOCATION EXHIBIT



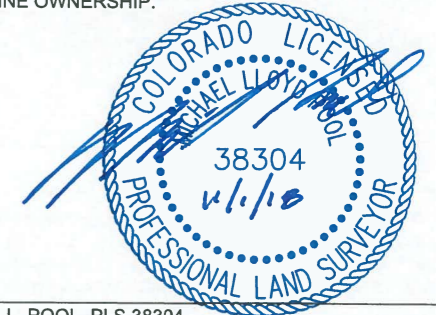
NOTES:

THIS LOW DISTORTION PROJECTION (LDP) IS BASED ON THE NORTH AMERICAN DATUM OF 1983, U.S. SURVEY FOOT WITH A LATITUDE ORIGIN OF 40.567905°N, A CENTRAL MERIDIAN LONGITUDE OF 104.773474°W, AND A SCALE FACTOR ON THE CENTRAL MERIDIAN OF 1.000235 (EXACT). 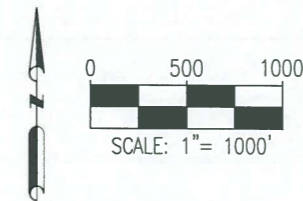
