On September 27, 2018 the HSR Bott, HSR Fischer 6-23 location was sampled to investigate for potential impacts subsequent to a produced water vessel removal, in accordance with COGCC Rule 905b. All soil samples collected were below COGCC Table 910-1 standards. Laboratory analytical results indicated sample GW02 exceeded the COGCC Table 910-1 allowable level for benzene at 22.6 micrograms per liter (µg/L).
