#### COMMENTS:

Bonanza Creek respectfully requests continued TA status. The 70 Ranch 13-27 well was plugged back @ 6422' with 2 sacks of cement 7/17/17. Form 5A to report AB status of Codell/Dakota/JSand was submitted 9/21/17 (Doc # 401407869); the well was SI and plugged back to offset HZ frac on Highpoint Operating Corporation (10071) Heltion 5-63-27 Pad. The well is closed to the atmosphere, locked out and tagged out at the master valve and the "Temporary SI for HZ Prep" sign is attached to the master valve. Well pressure tested on 11/13/2017 from 500-700#, held pressure for 15 minutes, test was good (Form 21 Doc# 401459565). Bonanza Creek has this well on their 2020 P&A Schedule, therefore are requesting continued TA status until such time as this well is P&A'd an annual TA sundry notice will be submitted in 1st Quarter 2020 to update the COGCC on the date of P&A.
