INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Initial Form 19 was submitted 2/18/2019. The surface area potentially impacted was 10 feet wide by 10 feet in length, approximately 100 square feet total. Snow pack kept the material from penetrating through the ice and into the ground surface. The temperature was 10F with no precipitation. The spill area was cleaned by scraping the material with a front-end loader, loading it into a transport truck, and hauling to Twin Enviro for disposal in Milner, CO. A Supplemental Form 19 was submitted 2/27/2019. The COGCC approved the Form 19 Supplemental with a condition of approval that soil samples be collected and submitted via Form 27.

On 3/5/2019, 1 soil grab sample was collected (1-2 inches in depth) from stockpiled impacted material waiting to be removed from location (SDE_PR_SS_01; 40.569537, -106.375307). Another soil grab sample was collected (1-2 inches in depth below ground surface) from the bottom of the excavation to confirm that all impacted material was removed (SDE_PR_SS_CFM_01; 40.569595, -106.37621). Samples were screened for the presence of hydrocarbons with a photoionization detector (PID) and submitted to Pace/ESC Labs for COGCC Table 910-1 Analyses.

SandRidge has completed all excavation and removal of impacted materials, which were loaded onto transport trucks and haul to Twin Enviro for disposal in Milner, CO.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

The spilled material and adjacent area was immediately cleaned by scraping the material with a front-end loader. The waste characterization sample, SDE_SS_R_01, collected from the stockpiled material had elevated concentrations of TPH, above Table 910-1 allowable concentrations. The confirmation sample collected from the excavation bottom, SDE_SS_RR_CFM_01, all analyses for organic compounds were below Table 910-1 concentrations. Both samples had arsenic concentrations above the Table 910-1 acceptable concentration. Sandridge is requesting relief from the Table 910-1 arsenic concentration limit of 0.39 mg/kg based upon the COGCC 2008 Rulemaking FAQ 31 response stating that "an operator need not meet a concentration level specified in Table 910-1 if the operator can demonstrate to the COGCC's satisfaction that the Table 910-1 level is exceeded by the background level in the native soils or groundwater, as applicable."
