COMMENTS:

Bonanza Creek respectfully requests continued TA status. The Guttensen Ranch 12-9 well was plugged back @ 6323' with 2 sacks of cement 11/26/2018. Form 5A to report TA status of Niobrara-Codell and J Sand was submitted 12/31/2018 (Doc #401883107); the well was SI and plugged back to offset HZ frac of Bonanza Creek's Wetco Farms A-4 Pad. The well is closed to the atmosphere, and the "Temporary SI for HZ Prep" sign is attached to the master valve. Well pressure tested 1200#, held pressure for 10 minutes, test was good. Bonanza Creek has this well on their 2019 P&A Schedule, therefore are requesting continued TA status until such time as this well is P&A'd. A Form 6 NOI has been submitted and approved by the COGCC (Form 6 NOI Doc #401918585). Form 42 will be submitted to notify the COGCC of plugging procedures 48 hours in advance.
