Bonanza Creek respectfully requests continued TA status. The Wetco Farms L-4 was plugged back with a CIBP @ 6212' and 2 sacks of cement on 11/17/2018. Form 5A to report TA status of Nio/Codell was submitted 12/31/2018 (Doc # 401882619); the well was SI and plugged back due to offset HZ frac of Bonanza Creek's Wetco Farms A-4 Pad. The well is closed to the atmosphere locked out and tagged out at the master valve, and the a "Temporary SI for HZ prep" sign is attached to the master valve. Well pressure tested to 1200#, held pressure for 15 minutes, test was good. Bonanza Creek has this well on their 2020 P&A Schedule, therefore are requesting continued TA status until such time as this well is P&A'd an annual TA sundry notice will be submitted in 1st Quarter 2020 to update the COGCC on the date of P&A.
