COMMENTS:

Bonanza Creek respectfully requests continued TA status. The DOW 41-33 well was plugged back with a CIBP @ 6212' and 2 sacks of cement 11/12/2018. Form 5A to report TA status of Niobrara-Codell was submitted 12/31/2018 (Doc #401881228); the well was SI and plugged back to offset HZ frac of Bonanza Creek's North Platte I-21 Pad. The well is closed to the atmosphere, and the "Temporary SI for HZ Prep" sign is attached to the master valve. Well pressure tested 500-700#, held pressure for 15 minutes, test was good. Bonanza Creek has this well on their 2019 P&A Schedule, therefore are requesting continued TA status until such time as this well is P&A'd. A Form 6 NOI has been submitted to the COGCC (Form 6 NOI Doc #401986895). Once Form 6 is approved, a Form 42 will be submitted to notify the COGCC of plugging procedures 48 hours in advance.
