5. TIH with CIBP. Set BP at 6730'. Top with 2 sxs 15.8#/gal CI G cement.
6. TIH with casing cutter. Cut 4 1/2" casing at 1700'. Pull cut casing.
7. TIH with tubing to 1820'. RU cementing company. Mix and pump 255 sxs 14.8#/gal Type III cement down tubing. TOC at 1098'.
8. Pick up tubing to 960'. Mix and pump 351 sxs 14.8#/gal Type III cement down tubing. Cement circulate to surface.
9. Cut surface casing 6' below ground level and weld on cap.
