Bonanza Creek respectfully requests continued TA status. The Dow 43-9 was plugged back with CIBP @ 6294' with 2 sacks of cement on 10/8/2018. Form 5A to report AB status of Nio/Codell was submitted 1/24/2019 (Doc # 401904996). This well was SI and plugged back due to sub economic production. Well pressure tested to 1000psi, held pressure for 15 minutes, test was good. Bonanza Creek has this well on their 2019 P&A Schedule, therefore are requesting continued TA status until such time as this well is P&A'd. A Form 6 NOI has been submitted and approved (Form 6 Doc# 401918324). A Form 42 will be submitted to notify the COGCC of plugging procedures 48 hours in advance of plugging procedures.
